System of controls

This is the set of actions which all schools must take. They are grouped into ‘prevention’ and ‘response to any infection’.

Prevention

- 1) minimise contact with individuals who are unwell by ensuring that those who have coronavirus (COVID-19) symptoms, or who have someone in their household who does, follow all government and school guidelines.
- 2) clean hands thoroughly more often than usual
- 3) ensure good respiratory hygiene by promoting the ‘catch it, bin it, kill it’ approach
- 4) introduce enhanced cleaning, including cleaning frequently touched surfaces often, using standard products such as detergents and bleach
- 5) minimise contact between individuals and maintain social distancing where appropriate
- 6) where necessary, wear appropriate personal protective equipment (PPE)
 - *Numbers 1 to 4 must be in place in all schools, all the time.*
 - *Number 5 must be properly considered and schools must put in place measures that suit their particular circumstances.*
 - *Number 6 applies in specific circumstances.*

Response to any infection

- 7) engage with the NHS Test and Trace process
- 8) manage confirmed cases of coronavirus (COVID-19) amongst the school community

First Aid	Spread of Infection due to close contact	Pupils Staff	<p><u>Covid-19: advice for first aiders</u></p> <p>1. Be aware of the risks to yourself and others When approaching a casualty there is always a risk of cross contamination – especially when you may have to get close to the casualty to assess what is wrong or to check their breathing. It is always important to be aware of the risks of how this cross contamination has occurred. According to NHS 111 we do not know exactly how coronavirus spreads from person to person but similar viruses are spread in cough droplets.</p> <p>2. Keep yourself safe In line with government advice, make sure you wash your hands or use an alcohol gel, before and after treating a casualty also ensure that you don't cough or sneeze over a casualty when you are treating them. The Resuscitation Council (UK) provides some useful advice of how to keep yourself safe when providing CPR. You can read their full advice on their website here. Don't lose sight of other cross contamination that could occur that isn't related to COVID-19.</p> <ul style="list-style-type: none"> ○ Wear face masks if possible if you are unable to maintain social distancing to treat a person ○ Wear gloves or cover hands when dealing with open wounds ○ Cover cuts and grazes on your hands with waterproof dressing ○ Dispose of all waste safely ○ Do not touch a wound with your bare hand ○ Do not touch any part of a dressing that will come in contact with a wound. <p>3. Give early treatment The vast majority of incidents do not involve you getting close to a casualty where you would come into contact with cough droplets. Sensible precautions will ensure you are able to treat a casualty effectively.</p> <p>4. Keep yourself informed and updated</p>	Med
